Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.			
	Nonaffiliates we share with can include the retailer named on your account and direct marketing companies.			
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.			
	Our joint marketing partners include insurance companies.			

## Other important information

If your account has a California or Vermont billing address, you are automatically treated as if you have chosen to limit our sharing of information with affiliates and nonaffiliates. If your account has a California billing address, we will not share information for joint marketing purposes with other financial companies. If your account no longer has a California or Vermont address, these special rules will stop applying and you will need to notify us if you want to exercise your right to restrict our sharing of information with affiliates or nonaffiliates.

\*Please keep in mind that, as permitted by federal law, if you choose to limit our sharing of information with nonaffiliates, your choice will not prohibit us from sharing your information with DICK'S Sporting Goods, Inc. (and its affiliates) in connection with maintaining and servicing the ScoreRewards Mastercard® and ScoreRewards Credit Card programs, including marketing of such programs.

The above notice applies only to consumer ScoreRewards Mastercard and ScoreRewards Credit Card Accounts with Synchrony Bank and does not apply to any other accounts you have with us. It replaces our previous privacy notice disclosures to you. We can change our privacy policy at any time and will let you know if we do if/as required by applicable law.
